20180705-01 – PRESSURE WASHER UPDATE Effective for Purchase Orders (POs) written after June 30th, all new pressure washers must be tested to the Pressure Washer Manufacturers' Association (PWMA) standard PWMA PW101-201. Test results per this standard must be within +/- 10% of claimed pressure.	ALL PRESSURE WASHER VENDORS
20180705-02 – FOOD QUALITY SYSTEM AUDIT REQUIREMENTS The purpose of this change is to align with the Food Safety Modernization Act (FSMA). This change will ensure that all food vendors participate in an established Global Food Safety Initiative (GFSI) audit program and have a current Food Product Recall Plan.	ALL FOOD VENDORS
20180705-03 – INSPECTION LEVEL AND AQLS UPDATE In an effort to standardize inspection levels and Acceptance Quality Limits (AQLs) across all product types, effective June 30th, inspection levels, Sample Size, AQLs and Sampling Plan charts have changed for HSN Pre-Shipment Onsite Field Inspections.	ALL JEWELRY, APPAREL, ACCESSORIES, FOOTWEAR, HANDBAGS, BEAUTY, HARDLINES, LUGGAGE, TEXTILES AND FOOD VENDORS
